**TERMS AND CONDITIONS**

1. The undersigned reserve the right to reject any or all tenders without assigning any reason there to.
2. The telegraphic/ conditional tender will not be accepted.
3. Tenders shall be received and opened on next day in case if it falls holidays on the scheduled date.
4. Detailed N.I.T. along with specifications, drawing and other terms and conditions can be seen with the Member Secretary-cum-Principal, IMC of Govt. ITI Kasauli at Garkhal, on any working day.
5. The tender forms can be purchased from the office of the Member Secretary-cum-Principal, IMC of Govt. I.T.I. Kasauli, after making payment in cash/ Demand Draft from 5.10.2011 to 20.10.2011(1.00 P.M.) during the working days in working hours i.e. 10.00 AM to 5.00 PM.
6. Earnest money accompanying the tenders must be in the shape of Bank Draft payable at any Nationalized Bank at Kasauli, District Solan HP in favor of Member Secretary-cum-Principal, IMC of Govt. ITI Kasauli. Application for

tender from must be accompanied by attested copy of registration certificate, latest income tax clearance certificate, and registration under H.P. Sales Tax Act 1986 and requisite experience certificate of having successfully executed works of similar nature, without which the tender from will not be issued.

7. The tender rates shall remain valid for 120 days from the date of opening the tender. The quantities mentioned in tender are approximate and may change as per execution details at site, however the contractor will be paid on basis of unit rates.
8. Above mentioned works can be awarded separately.
9. The Applicant should meet the following minimum criteria for pre-qualification:
  - (I) Average Annual Financial Turnover during the last three financial years i.e. 2008-2009, 2009-2010 & 2010-2011 should be at least **30%** of the estimated cost for this project. Audited balance sheet to be submitted.
  - (II) Experience of having successfully completed similar works during last 7 years ending last day of month previous to the one in which applications are invited should be either of the following :
    - Three similar completed works costing not less than the amount equal to **40%** of the estimated cost.
    - Two similar completed works costing not less than the amount equal to **50%** of the estimated cost.

Or

- One similar completed works costing not less than the amount equal to **80%** of the estimated cost.
10. The work is of urgent nature and will have to be completed within the stipulated period otherwise the penalty of compensation for delay in completion will be imposed as per Rules.
11. The acceptance of the tender will rest with the undersigned who does not bind himself to accept the lowest tender.
12. The IMC reserves the right to withdraw, held or reduce the quantum of work during the tendency of this project.
